I understand that the terms "I", "we", "us" and any derivatives of these pronouns mean "I, on their behalf and mine", including with respect to any acceptance, cession or waiver set out below.

RESPONSIBILITY | I hereby authorize my child to participate in the au Parlement franco-canadian du Nord et de l'Ouest (PFCNO). I confirm that my child is autonomous enough to participate in the PFCNO. PFCNO activities may include, but are not limited to, meetings, workshops, conferences, events or social activities.

In consideration of my child's participation in the PFCNO (the sufficiency and value of such consideration being irrevocably acknowledged), I agree and accept the following:

RULES | Failure to comply with the participation policy set out below (attached to this consent form) could result in the loss of certain privileges for the participant, up to and including expulsion from the event and restricted access to future events. I confirm that I agree with these rules and the possible consequences of expulsion.

CANCELLATION | In the event that my child must cancel their participation in the PFCNO, I will advise the CJP as soon as possible by email at projets@cjpmb.ca, and by September 30<sup>th</sup>, 2024 at the latest. Please note that registration fees are non-refundable.

PERSONAL INFORMATION | I agree to the use of my child's personal information (last name, first name) on the website of the CJP and other event partners, if applicable, in accordance with the organization's privacy policy http://fjcf.ca/politique-de-confidentialite/.

ACCIDENT | I understand that the Conseil jeunesse provincial (CJP) and its representatives will take all necessary precautions to ensure the well-being and safety of each participant. However, I am aware that the CJP and its partners assume no responsibility for any injury, loss, damage or harm caused to a participant or their property during activities held as part of the PFCNO.



CAPTURE | As a parent or legal guardian of [child's name\_\_\_\_\_], I authorize the Conseil jeunesse provincial (CJP) to capture still and moving images and/or the voice of my child in the course of its activities, provided that their use is not prejudicial to their honour and reputation, and provided that such use is made in accordance with the consents contained in this form.

SOCIAL MEDIA | Photos and information published may be subject to unauthorized sharing or publication by the CJP, given the open nature of social media. I therefore agree not to hold the CJP and other partners responsible for any harm resulting from such unauthorized sharing or publication. The CJP and event partners, if any, may also freely publish these images and/or audio and/or video recordings as part of the promotion of its events or programs on its social media.

## **Participation Policy**

Please note that this **PARTICIPATION POLICY** applies to everyone who will participate (participant, facilitator, chaperone, etc.) in the 2024 Parlement franco-canadien du Nord et de l'Ouest (PFCNO). The code of conduct is applicable everywhere. We expect our participants to behave in the same manner they would at our face-to-face events and to abide by the code of conduct described below.

Failure to comply with the **Participation Policy** may result in the Cjp ordering sanctions up to and including expulsion from the PFCNO.

**ALCOHOL AND CANNABIS:** No consumption or possession of alcohol, cannabis, will be tolerated at any of the PFCNO venues nor during the social activities organized by the CJP for all participants. Anyone intoxicated by alcohol or cannabis will be sent home at their own expense.

**DRUGS:** No consumption or possession of drugs will be tolerated on site. Anyone in possession of drugs or intoxicated by them will be sent home at their own expense.

**TOBACCO AND VAPING:** No vaping and no consumption of tobacco will be tolerated on site. Those who wish to consume tobacco will have to do so in the designated areas flagged by the event organizers.

**HARASSMENT AND INTIMIDATION:** That at the PFCNO, all identities, accents and self-expressions are accepted and valued. Cjp and its partners are committed to providing a safe environment, free of harassment and discrimination. No form of harassment, sexual harassment or intimidation, whether physical, verbal or virtual, will be tolerated for the duration of the event. Anyone who does not respect these values will be sent home at their own expense.

**ATTENDANCE:** Everyone commits to being punctual, present, alert and attentive at all PFCNO activities. No one may leave the PFCNO sites without the permission of an CJP employee or a chaperone.

**OFFICIAL VENUE AND CURFEW:** Those <u>under the age of 18</u> may not leave the PFCNO sites unaccompanied, either by an CJP employee or by a designated member of their delegation. All participants must respect the curfew set by the PFCNO. Those <u>over the age of 17</u> may leave the PFCNO sites unaccompanied, but must notify either a Cjp employee or a designated member of their delegation and this must be done in a group of at least two people.

**COMPLIANCE WITH GUIDELINES:** Everyone must comply with the instructions given by the CJP and the PFCNO at all times.

## **Declaration and Confirmation**

I declare that I have discussed with my child the importance of them acting independently and responsibly throughout the entire PFCNO.
